Subject: Low cost import of Chapter 39 products leading to huge disadvantage for MSME's

Dear Sir,

Greetings from The All India Plastics Manufacturers' Association (AIPMA)

Refer to your communication dated 20<sup>th</sup> Nov 2020 w.r.t Challenges faced for import reduction.

This is to bring to your kind notice the recent trade anomalies witnessed by our industry members. Such anomalies if not addressed by the Ministry at the earliest would be a roadblock for the MSME's to become self-reliant and Atmnirbhar. In particular, MSME's in India are likely to get affected by such trade difficulties/manipulations.

This has come to our notice that foreign manufacturers having their offices in India are importing semi-finished and finished goods equivalent to the cost of import of raw material. Specifically, this has been witnessed in manufacturing of high performance engineering plastic stock shapes (like rods, plates, tubular bars) and CNC machined components of High Performance Plastics. These High Performance Engineering Plastics are known to exhibit excellent mechanical properties at elevated temperatures and are employed in demanding applications required by Defense, Energy, Space and Aviation segments which are of strategic importance for the country. Indian MSME's are working against many odds and have been catering to the Indian public sector and private sector users as "Make in India" products and thus contributing to the objective of "Atmnirbhar Bharat".

As mentioned, stock shapes of PEEK, a high performance engineering plastic, are being imported into India at a price which is comparable to imported PEEK raw material price of most reputed raw material producers thus rendering the local
