**Subject: URGENT REQUEST TO STOP THE PROCESS OF IMPOSING
NON-TARIFF BARRIER (MANDATORY BIS STANDARDS) ON
POLYMERS (PLASTICS RAW MATERIAL)**

1. Plastics processing industry is trying its best to stand back on its feet after the lockdown and demand destruction due to the ongoing pandemic.
2. Plastics processing industry consisting of 50,000 units (90% are MSME's) have witnessed dramatic increase in cost of Raw material in last 4-5 months. In some key raw material, the cost has gone up by as much as 130 percent.
3. Industry is also facing acute shortage of raw material leading to disruption in their production schedules.
4. In most of the raw material, the industry is dependent on imports as domestic polymer manufactures don't have sufficient capacity or production to meet the domestic demand.
5. Processing industry in India is on the verge of major existential crisis due to the exponential price increase and shortage of raw material in India. We are afraid that the above developments would lead to closure of various units and job losses across the country.

6. The industry is of the firm view that imposing Non-tariff barrier such as mandatory BIS standards on raw material at this stage would further add fuel to the fire and destroy MSME's in plastics processing sector.
7. Polymer production is a standardized process all over the world and the product conforms to international standards as mentioned in their Technical Data sheets. Adding another layer of standards serves no fruitful purpose, rather makes the ease of doing business for Indian MSME's more difficult. ISO standards are international standards which are widely accepted by all countries. BIS can go ahead with making standards for those item wherein there are no standards currently. However, BIS standards should not be made mandatory. ISO / EU/ASTM standards should also be acceptable as it ensures import of quality material.

Imposing Non-Tariff Barrier such as mandatory BIS standards would lead to increase in imports of finished goods, since not being governed by any quality standards, will be freely imported at cheap prices and also at inverted custom duties thereby ensuring the collapse of the plastic processing industry in India thereby jeopardizing livelihood of millions of families.
9. Export of plastics finished products is likely to take a big hit as Indian plastics processors would become highly uncompetitive in the global market due to proposed Non-tariff barriers planned by the Department.

In view of the above, we request you to immediately stop the process of making BIS standards mandatory on Plastics Raw materials. Halting the above process would be in greater interest of Indian MSME's in the plastics sector. It may play a key role in survival of MSME's in plastics processing sector.
